VETERINARY PUBLIC HEALTH ORDINANCE, 1999
ANTI-RABIES VACCINATION ORDER

(Made under section 40 (1))

In exercise of the powers conferred by section 40(1) of the Veterinary Public Health Ordinance, 1999 [*Cap. 32*], the Minister for Modernisation of Agriculture, Native Land and Regional Development, hereby order that all dogs in the State of Sarawak (in the declared and non-declared rabies-infected areas) to be subjected to anti-rabies vaccination.

2. This Anti-Rabies Vaccination Order shall remain in force until such time that the Order is revoked.
3. *Gazette* Notification No. *Swk. L.N. 105/2017* dated 6th day of July, 2017, is revoked.

**THE LAND (DEALING IN NATIVE AREA LAND)
(AUTHORIZATION) (NO. 3) NOTIFICATION, 2018**

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [*Cap. 81 (1958 Ed.)*], and delegated to the State Secretary by a delegation vide *Swk. L.N. 55/95*, the following Notification has been made by the State Secretary:

Citation and commencement

1. This Notification may be cited as the **Land (Dealing in Native Area Land) (Authorization) (No. 3) Notification, 2018**, and shall be deemed to have come into force on the 24th day of January, 2018.

Authorization to deal in Native Area Land
