VETERINARY PUBLIC HEALTH ORDINANCE, 1999

DECLARATION OF AFRICAN SWINE FEVER (ASF) DISEASE CONTROL AREA

(Made under section 35(1)

In exercise of the powers conferred by section 35(1) of the Veterinary Public Health Ordinance, 1999 *[Cap. 32]*, the Minister for Modernization of Agriculture, Native Land and Regional Development, has made the following order to declared Miri Division as an African Swine Fever Disease Control Area. This Order impose all control measures and any other provisions that are necessary to prevent the introduction of African Swine Fever Disease into Sarawak.

This African Swine Fever Control Order shall remain in force until such time this Order is revoked.

THE LAND CODE

THE LAND (DEALING IN NATIVE AREA LAND) (FINANCIAL INSTITUTION) NOTIFICATION, 2021

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [Cap. 81 (1958 Ed.)], the Majlis Mesyuarat Kerajaan Negeri has made the following Notification:-

Citation and commencement

1. This Notification may be cited as the **Land** (**Dealing in Native Area Land**) (**Financial Institution**), **Notification 2021**, and shall be deemed to have come into force on the 26th day of August, 2021.

Declaration and Authorization to deal in Native Area Land

2. Koperasi Co-OpBank Pertama Malaysia Berhad (Reg. No. 1146), a company registered or incorporated under the Akta Koperasi 1993, with a registered address at Tingkat 6, Wisma JcbNext, No. 27 Lorong Medan Tunku 1, off Jalan Sultan Ismail, 50300 Kuala Lumpur, shall be deemed to be a Native of Sarawak for the purpose or in respect of dealing with all the areas of land affecting Native Area Land, registered in the name of a Native of Sarawak.
