THE CONSTITUTION OF THE STATE OF SARAWAK

THE STATE PUBLIC SERVICE COMMISSION
(DELEGATION OF POWERS) DIRECTION, 2019

(Made under Article 36(6))

In exercise of the powers conferred upon the State Public Service Commission by Article 36(6) of the Constitution of the State of Sarawak [*G.N.S. 163/63*], the following Direction has been made:

Citation and commencement

1. This Direction may be cited as the **State Public Service Commission (Delegation of Powers) Direction, 2019**, and shall be deemed to have come into force on the 1st day of January, 2018.

Delegation of powers of the State Public Service Commission to the State Secretary

2. It is directed that the power conferred upon the State Public Service Commission under Article 36(1) of the Constitution of the State of Sarawak [*G.N.S. 163/63*] to promote officers belonging to the Support Group who have served for

thirteen (13) years or more, and are currently still in their first layer of promotion grade in the scheme of service, be delegated to the State Secretary.

Application of *Pekeliling Perjawatan Negeri Sarawak Bilangan 8 Tahun 2019*

3. The exercise of such powers by the State Secretary shall be in accordance with the *Pekeliling Perjawatan Negeri Sarawak Bilangan 8 Tahun 2019*.

Information and record

4. Whenever any promotion is made pursuant to paragraph 2, a copy of the instrument pertaining thereto shall be extended to the State Public Service Commission for its information and record.

Revocation

5. The State Public Service Commission (Delegation of Powers) (No. 1) Direction, 2015 [*Swk. L.N. 292/2015*] is revoked.

THE MUARA TUANG LAND DISTRICT
(MIXED ZONE LAND) (NO. 12) DECLARATION ORDER, 2019

(Made under section 4(1))

In exercise of the powers conferred upon the Minister by section 4(1) of the Land Code [*Cap. 81 (1958 Ed.)*], the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Muara Tuang Land District (Mixed Zone Land) (No. 12) Declaration Order, 2019**, and shall be deemed to have come into force on the 28th day of June, 2013.

Declaration of Mixed Zone Land in Samarahan Division

2. The area of land described in the Schedule has been declared as Mixed Zone Land.

1. This Order may be cited as the **Salak Land District (Mixed Zone Land) (No. 3) Declaration Order, 2019**, and shall be deemed to have come into force on the 27th day of November, 2012.

Declaration of Mixed Zone Land in Kuching Division

2. The area of land described in the Schedule has been declared as Mixed Zone Land.

THE LAND CODE

THE LAND (DEALING IN NATIVE AREA LAND)
(AUTHORIZATION) (No. 27) NOTIFICATION, 2019

(Made under section 9(1))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [*Cap. 81 (1958 Ed.)*], and delegated to the State Secretary by a delegation vide *Swk. L.N. 55/95*, the following Notification has been made by the State Secretary:

Citation and commencement

1. This Notification may be cited as the **Land (Dealing in Native Area Land) (Authorisation) (No. 27) Notification, 2019**, and shall be deemed to have come into force on the 14th day of May, 2019.

Authorization to deal in Native Area Land

2. Highome Development Sdn. Bhd. (Co. No. 324282-K) with an address at Lot 775, Lorong Demak Maju 8, Demak Laut Industrial Park, 93900 Kuching, Sarawak (“the Company”), shall be deemed to be a native of Sarawak for the purpose to deal with a parcel of Land described as Lot 3083 Block 18 Salak Land District, subject to the following condition:

(a) this authorization shall have no effect as regards to any Native Area Land which has been reserved or set aside for road or reserved by the Government for public purposes or for any other development purposes as may be determined by the State Planning Authority;

(b) the shares of the Company shall be held entirely by the Bumiputeras permanently residing in Sarawak and no transfer of shares of the Company shall be registered or erected by the Company without the prior consent in writing of the Minister for the time being responsible for land; and

(c) upon the sale or disposal of the said Land the Company shall ceased to be deemed a native of Sarawak unless there is a written direction to the contrary effect issued by the State Secretary, Sarawak.
