DISTRIBUTION OF GAS (APPOINTMENT OF GAS AGGREGATOR)
ORDER, 2024

(Made under section 7A(1))

In exercise of the powers conferred by section 7A(1) of the Distribution of Gas Ordinance, 2016 [*Cap. 72*], the Majlis Mesyuarat Kerajaan Negeri has made the following Order:

Citation and commencement

1. This Order may be cited as the **Distribution of Gas (Appointment of Gas Aggregator) Order, 2024**, and shall come into force on the 1st day of February, 2024.

Appointment of Gas Aggregator
