THE SENTAH-SEGU LAND DISTRICT (NATIVE AREA LAND)
(No. 3) DECLARATION NOTIFICATION, 2025

(Made under section 4(3))

In exercise of the powers conferred upon the Director by section 4(3) of the Land Code [*Cap. 81 (1958 Ed.)*], and with the approval of the Minister, the following Notification has been made:

Citation and commencement

1. This Notification may be cited as the **Sentah-Segu Land District (Native Area Land) (No. 3) Declaration Notification, 2025**, and shall be deemed to have come into force on the 16th day of January, 2019 .

Declaration of Native Area Land in Serian Division

2. The area of land described in the Schedule is hereby declared to be Native Area Land.

THE NATIVE COMMUNAL RESERVE (EXCISION)
(NO. 60) DECLARATION ORDER, 2025

(Made under section 6(4))

In exercise of the powers conferred upon the Minister by section 6(4) of the Land Code [*Cap. 81 (1958 Ed.)*], the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Native Communal Reserve (Excision) (No. 60) Declaration Order, 2025**, and shall be deemed to have come into force on the 16th day of January, 2019.

Excision of land from Native Communal Reserve

2. The area of land described in the Schedule shall ceased to form part of the Native Communal Reserve (Agriculture) constituted by *Gazette* Notification No. *Swk. L.N. 89* dated 29th day of May, 2017.

Amendment of Schedule to Swk. L.N. 89/2017

3. Schedule to *Gazette Notification No. Swk. L.N. 89/2017* is hereby varied accordingly.
