THE LOCAL AUTHORITIES ORDINANCE, 1996

THE DALAT AND MUKAH DISTRICT COUNCIL  
(VESTING OF PUBLIC PLACES) ORDER, 2024

(Made under section 99(1))

In exercise of the powers conferred upon the Majlis Mesyuarat Kerajaan Negeri by section 99(1) of the Local Authorities Ordinance, 1996 [*Cap. 20*], and vested in the Ministry of Natural Resources and Urban Development by a delegation vide *Swk. L.N. 74/98*, the following Order has been made:

**Citation**

1. This Order may be cited as the **Dalat and Mukah District Council (Vesting of Public Places) Order, 2024**.

**Vesting of certain public places in Dalat and Mukah District Council**

2. The public places described in Columns (2), (3), (4) and (5) of the Schedule have been vested in the Dalat and Mukah District Council with effect from the dates specified in Column (7), subject to the respective conditions set out in Column (6).
