THE CHARITABLE TRUSTS ORDINANCE, 1994

THE YAYASAN TAHFIZ SARAWAK CHARITABLE TRUST DECLARATION, 2025

(Made under section 3(1))

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 *[Cap. 7]*, the Yang di-Pertua Negeri has made the following Declaration:

Citation and Commencement

1. This Declaration may be cited as the **Yayasan Tahfiz Sarawak Charitable Trust Declaration, 2025**, and shall be deemed to have come into force on the 1st day of March, 2025.

Declaration of Charitable Trust

- 2. It is hereby declared that—
- (a) a Charitable Trust shall be created and be known as the Yayasan Tahfiz Sarawak Charitable Trust;

- (b) the trust properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [Cap. 7];
- (c) the beneficiaries of the Yayasan Tahfiz Sarawak Charitable Trust shall be the religious and Tahfiz schools registered under the Majlis Islam Sarawak Ordinance, 2001 [Cap. 41], together with their students, teachers and staffs; and
- (d) the purposes of the Yayasan Tahfiz Sarawak Charitable Trust are as set out in the Second Schedule.

FIRST SCHEDULE

(Paragraph 2(b))

TRUST PROPERTIES

- (1) Fund which have been or shall be donated, collected or pledged for the Charitable Trust purposes stipulated under the Second Schedule.
- (2) Contributions, donations and gifts from Government, any institutions, corporations and any other persons or individuals or sources for purposes of the Charitable Trust, including any legacies and properties bequeathed by will or other instruments for the Charitable Trust purposes set out under the Second Schedule.
- (4) Land, building and other properties or assets, movable and immovable, including moneys, bonds and shares acquired or held or controlled for the purposes of the Charitable Trust.

SECOND SCHEDULE

(Paragraph 2(d))

TRUST PURPOSES

- (1) To provide assistance for the development or physical improvement that benefits tahfiz schools and religious schools in Sarawak.
- (2) To allocate funds, develop, maintain and enhance any movable or immovable assets utilized by the Charitable Trust for the advancement of tahfiz schools and religious schools in Sarawak.
- (3) To implement any activities, initiative or studies aimed at advancing holistic education, promoting Islamic values, strengthening good governance and safeguarding the welfare of community religious schools in Sarawak.
