VETERINARY PUBLIC HEALTH ORDINANCE, 1999

ANTI-RABIES VACCINATION ORDER

(Made under section 40 (1))

In exercise of the powers conferred by section 40(1) of the Veterinary Public Health Ordinance, 1999 [*Cap. 32J*], the Minister for Modernisation of Agriculture, Native Land and Regional Development, hereby order that all dogs in the State of Sarawak (in the declared and non-declared rabies-infected areas) to be subjected to anti-rabies vaccination.

2. This Anti-Rabies Vaccination Order shall remain in force until such time that the Order is revoked.
3. *Gazette* Notification No. *Swk. L.N. 16/2018* dated 7th day of February, 2018, is revoked.
