THE LAND CODE

THE LAND (DEALING IN NATIVE AREA LAND)
(AUTHORIZATION) (NO. 20) NOTIFICATION, 2026

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [Cap. 81 (1958 Ed.)], and delegated to the State Secretary by a delegation *vide* Swk. L.N. 55/1995, the State Secretary has made the following Notification:

Citation and commencement

1. This Notification may be cited as the **Land (Dealing in Native Area Land) (Authorization) (No. 20) Notification, 2026**, and shall be deemed to have come into force on the 16th day of April, 2026.

Authorization to deal in Native Area Land

2. BORNEO TO THE WORLD SDN. BHD. [Co. Reg. No. 200901030967 (8740746-H)], a company registered or incorporated under the Companies Act 2016, with a registered address at Lot 459, Block 14, Jalan Sultan Tengah, 93050 Petra Jaya Kuching, Sarawak (hereinafter referred to as “the Company”), shall be deemed to be a Native of Sarawak for the purpose to deal with all the areas of land described in the Schedule, subject to the following conditions:

(a) this authorization shall have no effect as regards to any Native Area Land which has been reserved or set aside for road or reserved by the Government for public purposes or for any other development purposes as may be determined by the State Planning Authority;

(b) the shares of the Company shall be held entirely by the Bumiputera permanently residing in Sarawak and no transfer of shares of the Company shall be registered or affected by the Company without the prior consent in writing from the Minister for the time being responsible for the land; and

(c) upon the sale or disposal of any of the said land, the Company shall cease to be deemed as a Native of Sarawak unless there is a written direction to the contrary effect issued by the State Secretary, Sarawak.

SCHEDULE

All that parcel of land containing an area of 3.73 hectares, more or less, and known as “*Kawasan Pembangunan Tanah Hak Adat Bumiputera di Kampung Rayu Matang, Bahagian Kuching*”.

(The boundary of the land described above is more particularly by delineated on Plan under file ref: MFICORD/900-5/5/1 (4), kept in the office of the Permanent Secretary, Ministry of Food Industry, Commodity and Regional Development (MFICORD), Sarawak.
