THE LAND (DEALING IN NATIVE AREA LAND) (AUTHORIZATION) (NO. 12) NOTIFICATION, 2025

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [Cap. 81 (1958 Ed.)], and delegated to the State Secretary by a delegation vide Swk. L.N. 55/1995, the State Secretary has made the following Notification:

#### Citation and commencement

1. This Notification may be cited as the Land (Dealing in Native Area Land) (Authorization) (No. 12) Notification, 2025, and shall be deemed to have come into force on the 14th day of February, 2025.
