Citation and commencement

1. This Order may be cited as the **Mukah Land District** (**Native Area Land**) (**No. 3**) **Declaration Order, 2025**, and shall be deemed to have come into force on the 30th day of July, 2003.

Declaration of Mixed Zone Land to the Native Area Land in Mukah Division

In exercise of the powers conferred upon the Minister by section 6(1) of the Land Code [Cap. 81 (1958 Ed.)], the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Native Communal Reserve** (**Agriculture**) (**No. 18**) **Declaration Order, 2025**, and shall be deemed to have come into force on the 21st day of September, 2022.

Declaration of Native Communal Reserve in Sibu Division

2. The area of land described in the Schedule has been declared as Native Communal Reserve for the exclusive use for agriculture by the Iban community of Batu 9 & 10, Jalan Kanowit/Julau/Durin (KJD), Sibu.

Citation and commencement

1. This Order may be cited as the **Native Communal Reserve (Excision)** (**No. 41) Declaration Order, 2025**, and shall be deemed to have come into force on the 17th day of November, 2015.

Excision of land from Native Communal Reserve
