THE SALAK LAND DISTRICT (NATIVE AREA LAND) DECLARATION ORDER, 2023

(Made under section 4(2))

In exercise of the powers conferred upon the Minister by section 4(2) of the Land Code [Cap. 81 (1958 Ed.)], the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Salak Land District (Native Area Land) Declaration Order, 2023**, and shall be deemed to have come into force on the 9th day of July, 2020.

Declaration of Mixed Zone Land to be Native Area Land in Kuching Division

2. The areas of unalienated Mixed Zone Land described in the Schedule are hereby declared to be Native Area Land.

KUCHING DIVISION SALAK LAND DISTRICT
