THE PORT AUTHORITIES ORDINANCE, 1961

BINTULU PORT AUTHORITY (SARAWAK)

(APPOINTMENT OF APPROVED PORT OPERATOR) NOTIFICATION, 2026

(Made under section 12(2)(a))

In exercise of the powers conferred by section 12(2)(a) of the Port Authorities Ordinance, 1961 [*Ord. No. 1/61*] (“the Ordinance”), the Bintulu Port Authority (Sarawak), with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

Citation and commencement

1. This Notification may be cited as the **Bintulu Port Authority (Sarawak) (Appointment of Approved Port Operator) Notification, 2026**, and shall be deemed to have come into force on the 1st day of September, 2026.

Appointment of approved port operator

2. Bintulu Port Authority (Sarawak) has, with the approval of the Majlis Mesyuarat Kerajaan Negeri, appointed BINTULU PORT SDN. BHD. (Co. No. 199201022892 (254396-V)) a company incorporated in Malaysia under the Companies Act 2016 [*Act 777*] and having its registered office at Lot 15, Block 20, Kemena Land District, 12th Mile, Tanjung Kidurong Road, 97008 Bintulu, Sarawak

("the Company") a wholly owned subsidiary of Bintulu Port Holdings Berhad as an approved port operator.

Duration of appointment

3. The appointment shall be deemed to have commenced from the 1st day of September 2026 for a period of 30 years and expiring on 31st day of August 2056.

Terms and Conditions

4. The Company as approved port operator shall perform, carry out or provide the port undertakings at Bintulu Port subject to the following:

(a) Comply fully with the provisions of the Ordinance and any By-laws, regulations or subsidiary legislation made pursuant to the Ordinance; and

(b) Such terms and conditions as spelled out in the Heads of Agreement entered into between the State Government of Sarawak, Bintulu Port Authority (Sarawak) and the Company. These terms and conditions shall continue to apply until a Port Operation Concession Agreement is duly executed by the State Government of Sarawak, Bintulu Port Authority (Sarawak) and the Company, upon which execution the Port Operation Concession Agreement shall be binding upon the Company and shall govern the operation of Bintulu Port by the Company.

Approved by the Majlis Mesyuarat Kerajaan Negeri on this 7th day of May, 2026.
