#### Citation and commencement

1. This Order may be cited as the **Native Communal Reserve** (**Agriculture**) (**No. 7**) **Declaration Order**, **2025**, and shall be deemed to have come into force on the 20th day of May, 2015.

#### **Declaration of Native Communal Reserve in Mukah Division**

2. The areas of land described in the Schedule have been declared as Native Communal Reserve for the exclusive use for agriculture by the Iban community of Batang Balingian, Mukah.
