THE LAND (DEALING IN NATIVE AREA LAND) (AUTHORIZATION) (NO. 49) NOTIFICATION, 2025

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [Cap. 81 (1958 Ed.)], and delegated to the State Secretary by a delegation vide Swk. L.N. 55/1995, the State Secretary has made the following Notification:

Citation and commencement

1. This Notification may be cited as the **Land** (**Dealing in Native Area Land**) (**Authorization**) (**No. 49**) **Notification**, **2025**, and shall be deemed to have come into force on the 31st day of October, 2025.
