THE SAMARAHAN LAND DISTRICT (NATIVE AREA LAND)
(No. 8) DECLARATION ORDER, 2024

(Made under section 4(3))

In exercise of the powers conferred upon the Director by section 4(3) of the Land Code [*Cap. 81 (1958 Ed.)*], and with the approval of the Minister, the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Samarahan Land District (Native Area Land) (No. 8) Declaration Order, 2024**, and shall be deemed to have come into force on the 8th day of September, 2020.

Declaration of Native Area Land in Samarahan Division

2. The area of land described in the Schedule has been declared as Native Area Land.

THE NATIVE COMMUNAL RESERVE (EXCISION) (No. 42) DECLARATION ORDER, 2024

(Made under section 6(4))

In exercise of the powers conferred upon the Minister by section 6(4) of the Land Code [*Cap. 81 (1958 Ed.)*], the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Native Communal Reserve (Excision) (No. 42) Declaration Order, 2024**, and shall be deemed to have come into force on the 9th day of July, 2020.

Excision of land from Native Communal Reserve (Agriculture)

2. The area of land described in the Schedule shall cease to form part of the Native Communal Reserve (Agriculture) constituted by *Gazette* Notification No. *Swk. L.N. 394/2019* dated 31st day of July, 2019.

Amendment of Schedule to *Swk. L.N. 394/2019*

3. The Schedule to *Gazette* Notification No. *Swk. L.N. 394/2019* is varied accordingly.
