THE LOCAL AUTHORITIES ORDINANCE, 1996

THE LOCAL AUTHORITIES (SEBUYAU DISTRICT COUNCIL) ORDER, 2024

(Made under section 3)

In exercise of the powers conferred by section 3 of the Local Authorities Ordinance, 1996 *[Cap. 20]*, the Yang di-Pertua Negeri has made the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Local Authorities (Sebuyau District Council) Order, 2024, and shall come into force on 1st day of October, 2024.

#### **Establishment of Sebuyau District Council**

2. It is declared that there shall be established in the Samarahan Division, a local authority of the status of a District Council to be known by the name of Sebuyau District Council.

## Administration of Sebuyau District Council

3.—(1) The Sebuyau District Council shall administer the area described and defined in paragraph (2)(*e*) under the Schedule to the Administrative Areas Order, 2022 [*Swk. L.N. 65/2022*], which shall be its area of jurisdiction for the purposes of the Local Authorities Ordinance, 1996 [*Cap. 20*].

(2) For the purpose of administering the Sebuyau District Council established under this Order, the Council shall—

(*a*) consist of a Chairman, a Deputy Chairman and not less than six and not more than thirty other Councillors appointed in accordance with section 12 of the Local Authorities Ordinance, 1996 [*Cap. 20*]; and

(b) have jurisdiction over all persons within its area of jurisdiction; and

(c) exercise all the powers and discharged all duties conferred on a local authority by the Local Authorities Ordinance, 1996 [*Cap. 20*] and any other written laws.

THE LOCAL AUTHORITIES (SIBURAN DISTRICT COUNCIL) ORDER, 2024

(Made under section 3)

In exercise of the powers conferred by section 3 of the Local Authorities Ordinance, 1996 *[Cap. 20]*, the Yang di-Pertua Negeri has made the following Order:

### **Citation and commencement**

1. This Order may be cited as the Local Authorities (Siburan District Council) Order, 2024, and shall come into force on 1st day of October, 2024.

#### **Establishment of Siburan District Council**

2. It is declared that there shall be established in the Serian Division, a local authority of the status of a District Council to be known by the name of Siburan District Council.

## **Administration of Siburan District Council**

3.—(1) The Siburan District Council shall administer the area described and defined in paragraph (3)(c) under the Schedule to the Administrative Areas Order, 2022 [Swk. L.N. 65/2022], which shall be its area of jurisdiction for the purposes of the Local Authorities Ordinance, 1996 [Cap. 20].

(2) For the purpose of administering the Siburan District Council established under this Order, the Council shall—

(*a*) consist of a Chairman, a Deputy Chairman and not less than six and not more than thirty other Councillors appointed in accordance with section 12 of the Local Authorities Ordinance, 1996 *[Cap. 20]*; and

(b) have jurisdiction over all persons within its area of jurisdiction; and

(c) exercise all the powers and discharged all duties conferred on a local authority by the Local Authorities Ordinance, 1996 [*Cap. 20*] and any other written laws.
