SARAWAK OMBUDSMAN ORDINANCE, 2023

SARAWAK OMBUDSMAN (REMUNERATION, ALLOWANCES, *ETC.*) ORDER, 2024

(Made under section 10(1))

In exercise of the powers conferred by section 10(1) of the Sarawak Ombudsman Ordinance, 2023 [*Cap. 84*] (“the Ordinance”), the Yang di-Pertua Negeri has made the following Order:

Citation and commencement

1. This Order may be cited as the **Sarawak Ombudsman (Remuneration, Allowances, *etc.*) Order, 2024**, and shall be deemed to have come into force on the 1st day of June, 2024.

Remuneration, Allowances, *etc.*

2. The Chief Ombudsman, Deputy Chief Ombudsman and Ombudsman appointed shall be entitled to such remuneration and allowances as stipulated below:

| Fixed allowance for JUSA | RM2,500.00 | RM1,500.00 | RM1,000.00 |
| Fixed Housing allowance | RM2,000.00 | RM1,600.00 | RM1,300.00 |
| Domestic helper allowance | RM500.00 | RM500.00 | RM500.00 |
| Total income | RM22,167.53 | RM18,764.19 | RM16,483.22 |

Other Allowances, etc.

(which includes subsistence allowances, travelling allowances, hotel accommodation expenses, medical facilities, leave, official car or any other allowances, etc.)

3. The Chief Ombudsman, Deputy Chief Ombudsman and Ombudsman of the Sarawak Ombudsman shall be entitled to the same allowances, privileges and entitlement which are applicable to public officers in the State Civil Service on the following grades–

- Chief Ombudsman - Same as Public Officers in JUSA A, VU5
- Deputy Chief Ombudsman - Same as Public Officers in JUSA B, VU6
- Ombudsman - Same as Public Officers in JUSA C, VU7

(Note: Official car only entitled to the Chief Ombudsman and Deputy Chief Ombudsman.)
