# THE LAND CODE

THE LAND (DEALING IN NATIVE AREA LAND) (AUTHORIZATION) (NO. 20) NOTIFICATION, 2022

(Made under section 9(1)(d))

In exercise of the powers conferred under section 9(1)(d) of the Land Code [Cap. 81 (1958 Ed.)], and delegated to the State Secretary by a delegation vide Swk. L.N. 55/1995, the State Secretary has made the following Notification:-

# Citation and commencement

1. This Notification may be cited as the Land (Dealing in Native Area Land) (Authorization) (No. 20) Notification, 2022, and shall be deemed to have come into force on the 25th day of February, 2022.

# Authorization to deal in Native Area Land

2. RANTAU TRUSAN SDN. BHD. (Co. Reg. No. 202101028727 (1429027-U)), a company registered or incorporated under the Companies Act 2016, with a registered address at Lot 9065, Section 64, 1st Floor, Jalan Tun Jugah, King's Centre, 93350 Kuching, Sarawak (hereinafter referred to as "the Company"), shall

be deemed to be a Native of Sarawak for the purpose to deal with all the areas of land described in the Schedule, subject to the following conditions:-
